Welcome to the new online format of our 2016 Annual report.

As the 2016 ACT elections approach, this year has been busy resolving a number of important policy issues that have been the focus on the MBA's advocacy efforts over the last term of government. In the last six months, the ACT government has worked closely with the MBA to finalise new building regulation laws which respond directly to the MBA's calls for improvements in building quality, a local industry participation policy has been released, and changes to residential solar access rules were finalised.

2016 was also a critical year for the construction industry as we remain focused on responding to the outcomes of the Royal Commission into Trade Union Corruption. In the ACT early 2016 marked the point when existing CFMEU Enterprise Bargaining Agreements (EBAs) expired. The ACT construction industry has lead the nation in rejecting union EBAs and exercising their freedom to enter new EBAs which give employees better working conditions and flexibility, and improve industry productivity.

In late 2016 the ACT will begin a new phase following the ACT elections. Regardless of the political party in power the MBA will work with the government to improve the economic environment so that the local construction industry can thrive.

The MBA ACT's success is largely due to the passion, expertise, and solutions-focused attitude of our members. Many of our members volunteer their time on various sector councils, boards, policy groups and workshops for the good of the construction industry. I thank all of our members for their contribution over the last year and for the years ahead. Special thanks go to out-going President Valdis Luks for his contribution, leadership and drive during his term as MBA President.


