



AWARD WAGE SUMMARY: BUILDING AND CONSTRUCTION GENERAL ON-SITE AWARD 2010 For period 1 November 2020 to 30 June 2021

This wage sheet sets out base rates and all-purpose rates of pay for employees covered by the Building and Construction General On-Site Award 2010 which come into effect for the period from 1 November 2020 to 30 June 2021.

Due to COVID-19 and its economic impacts, annual wage increases will take effect from 1 November 2020.

The following expense related allowances have increased from 1 November 2020:

- Meal Allowance (clause 20.2)
- Tool Allowance (clause 20.1)
- Compensation for tools and clothes (clause 20.3)
- Living Away from Home Allowance (clause 24)

This wage summary is not inclusive of all Award entitlements nor is it intended to replace the Award contents. Users of this Wage Summary will note that the rates of pay contained in this Wage Summary have been divided into two sectors: residential or general building and construction, as defined in the Award.

Explanation of the terms used in this Wage Summary:

Base rates are hourly rates, exclusive of any allowances or loadings. Those wishing to find out the equivalent rates for a daily hire worker should contact MBA ACT on (02) 6175 5900.

All-purpose rates are the minimum rates that must be paid to employees for all hours of work (including RDOs) and which are generally used for 'all purposes' of the Award, e.g. the calculation of loadings. All-purpose rates include base rates, plus 'all-purpose' allowances.

The **all-purpose allowances** included in the all-purpose rates below are the industry allowance and (for tradespersons) the tool allowances (as applicable). Note that **additional all-purposes may apply**, which are **not** included in the all-purpose rates below. Please refer to the allowance section at the end of this wage sheet.

Common additional (non-all purpose) allowances may also apply, such as the travel allowance (\$17.43 per day) and the overtime meal allowance (\$15.71 per day). For further details and other allowances refer to the table of contents and the relevant section of the allowances contained in this summary.

Travel time to the distant work location and return must also be paid at all purpose rates, along with a \$15.71 meal allowance per meal while traveling, plus a \$20.81 tool transport allowance on return. If an employee returns home on the weekend they are entitled to \$35.28 per occasion as long as the employer is notified on the preceding Tuesday.

Distant work payment (cl 25.4(b))

If an employee is required to travel to a construction site not located in the metropolitan radial area where the employee usually resides and is > 50 kilometres from their usual place or residence will be entitled to the following payment:

- (a) Payment for time outside ordinary working hours spent in travel, paid at the ordinary time hourly rate, calculated to the next quarter of an hour and with a minimum of one half an hour per day for each return journey; and
- (b) An expenses necessarily and reasonably incurred in such travel, which will be \$0.47 per kilometre where the employee uses their own vehicle.
