Welcome Message

This financial year has presented many challenges for our industry, with MBA members contending with the COVID-19 pandemic, bushfires and a hailstorm. But it's been amazing to see how well our industry has adapted to the 'new normal'. This difficult period has seen innovation and information at the forefront of all work at Master Builders ACT. This includes:

- MBA Group Training introduced remote training for apprentices and across short courses.
- Over 259 member communications were sent over the financial year, including industry news, the latest COVID-19 information, fact sheets and information about our lobbying to the ACT Government.
- We responded to over 3,000 member inquiries, with questions ranging from information about COVID-19, member event queries, our range of short courses as well as IR and Legal guidance.
- We continued to focus on our digital strategy, by implementing new software systems including a learning management system, Events management system and a new finance system.

- MBA was the only training provider in the ACT to continue to train apprentices and offer high risk licence training to the industry during the peak of COVID-19 in the ACT.
- Over the last year we have continued to call for the ACT Government to reduce red tape, release a future pipeline of work and to commence work on large scale projects.
- In March 2020 we called for the construction industry to be classified as an essential service during the COVID-19 lockdown period. The Master Builders ACT team worked diligently to provide COVID-19 site signs, health and safety guidance and helpful resources.
- Sector meetings and member workshops transitioned to a new digital format, to allow for COVID-19 social distancing restrictions.

We would like to thank Master Builders ACT members who have engaged with the Association and continued to support us over the last year. We thank you for your trust in our organisation and we look forward to what our industry will achieve in the financial year ahead.

Achievements

The 2019-20 year saw the entire world hit by the COVID-19 pandemic. The MBA was not immune to the effects of COVID-19, and it took significant adjustment from our members and staff to comply with the changing health and safety guidelines. Despite the impacts of COVID-19, we saw a number of exciting developments over the financial year.

There are a number of achievements to be highlighted from the 2019-20 financial year:

- MBA has remained a fierce advocate for the building and construction industry, in May 2020 we made a submission to the ACT Government calling on them to support our industry. The submission included 16 proposed stimulus measures on how the ACT economy could be supported, and in particular, the construction industry throughout COVID-19.
- MBA Group Training delivered a number of new courses, including Residential Construction Safety, Emergency Response Training, Mental Health Workshops and Emergency Controllers Training ECO Training.
- MBA Group Training introduced remote training for Apprentices and across our short courses.
- A record number of projects were entered in the 2020 Excellence Awards and the 2020 CCF Earth Awards.
- Delivered the first digital only edition of Canberra Builder in June 2020.

Across Member Services:

- Master Builders ACT launched a new member service, eDocs, allowing members to purchase contracts online.
- We welcomed over 3,400 attendees to our member events - both in person prior to COVID-19, and online since. This includes topics such as Right of Entry, WHS Obligations, Accounting, Tax, Award Changes and more.

In the building and construction industry:

- Three Master Builders ACT members received awards in the 2019 MBA Australia National Business Leadership Awards. Congratulations to New Level Landscapes, Guideline ACT and Complex Co.
- Master Builders ACT members, Manteena Commercial and Shaw Building Group, delivered the COVID-19 ACT emergency hospital build in just 37 days in May 2020.
- The Federal and ACT Governments released the HomeBuilder grant which provides eligible owner-occupiers with a grant of \$25,000 to build a new home or substantially renovate an existing home. The grant was aimed at encouraging new builds and renovations to support the residential construction sector.
- The Federal Government also announced the JobKeeper stimulus measure, which helped our members retain their staff members, The scheme allowed eligible businesses to receive up to \$1,500 a fortnight per eligible employee. The scheme was recently extended until March 2021, which will provide much need support for the construction industry.
